ORDINANCE OF THE TOWNSHIP OF WEST MILFORD, COUNTY OF PASSAIC, STATE OF NEW JERSEY AMENDING CHAPTER 226 “NOISE” TO CORRECT OMISSIONS FROM THE STATE’S MODEL NOISE ORDINANCE

SUMMARY, NOISE ORDINANCE CORRECTION, on September 16, 2020 a noise ordinance 2020-025 was adopted to comply with the DEP’s Model Noise Ordinance. One section had been mistakenly omitted in drafting the ordinance and this new ordinance adds the omitted section, corrects references necessitated by the added section and renumbers the subsequent sections. The ordinance has been approved by the DEP in the new corrected ordinance and does not need to be resubmitted.

Take notice that the foregoing Ordinance was introduced and passed on first reading at the Workshop Meeting of the West Milford Township Council held on October 7, 2020 and was ordered published according to law and will be further considered for final adoption at a meeting of the West Milford Township Council to be held on October 21, 2020, at the West Milford Township Municipal Building, 1480 Union Valley Road, West Milford, New Jersey at 6:30 p.m. prevailing time at which time and place all interested parties may appear and be heard.
