**RESOLUTION OF THE TOWNSHIP OF WEST MILFORD, COUNTY OF PASSAIC, STATE OF NEW JERSEY AUTHORIZING THE RENEWAL OF PLENARY RETAIL CONSUMPTION LICENSES WITH CONDITIONS FOR THE 2012- 2013 LICENSE YEAR**

**WHEREAS**, an application for renewal of Plenary Retail Consumption Licenses for the 2012-2013 License year has been received and reviewed; and

**WHEREAS**, the Township Council has conducted a public review of the applications as stipulated in the guidelines of the Director of the Division of Alcoholic Beverage Control dated April 14, 1980; and

**WHEREAS**, as a result of that review the Township Council has determined as follows:

1. The submitted applications are complete in all respects.
2. The applicants are qualified to be licensed according to all statutory, regulatory and local governmental A.B.C. laws and regulations.
3. The applicants have disclosed to the issuing authority the source of all additional financing obtained in the previous license year (July 1, 2011- June 30, 2012).

**WHEREAS**, the Police Department has recommended that the licenses be renewed to the current owners as active licenses with conditions.

**NOW, THEREFORE, BE IT RESOLVED** that the Township Clerk is directed to issue the license certificates for the Mayor and Township Council of the Township of West Milford.

Amplified music should be restricted to the interior of the building only. This pertains to both live music and a DJ. Any musical entertainment outside of the building should cease by 9 p.m.</li> <li>2. Persons are not to leave the property of the licensed premise or the extended premise with alcoholic beverages. A written notice advising patrons of this is to be posted.</li> <li>3. A maximum occupancy should be set for the outside area.</li> <li>4. Outside area is to be closed and vacated by 10 p.m.</li> <li>5. A fire extinguisher (2-A:10-B:C) shall be hung – mounted on the outside, left side of the building, near side door. Unit shall be clearly identified with a sign and covered by a fire extinguisher bag to be protected from the weather;</li> </ol>

	6. No key locking devices can be installed on either front nor rear exit fence gates; 7. Install plate exit signs on front and rear exit gates. Signs must be of "glow in the dark" design.
