RESOLUTION OF THE TOWNSHIP OF WEST MILFORD, COUNTY OF PASSAIC, STATE OF NEW JERSEY AUTHORIZING PURCHASES FROM CERTAIN APPROVED STATE CONTRACT VENDORS PURSUANT TO N.J.S.A. 40A:11-12 (A) AND AUTHORIZING PARTICIPATION IN AND CONTRACTS WITH VENDORS UNDER COOPERATIVE PRICING SYSTEMS PURSUANT TO N.J.S.A. 40A:11-11(6)

WHEREAS, the Township of West Milford, pursuant to N.J.S.A.40A:11-12 (a) and N.J.A.C. 5:34-7.29 (c), may, by this resolution and a properly executed purchase order and without advertising for bids, purchase any goods or services under any contract or contracts for such goods or services entered into on behalf of the State by the Division of Purchase and Property; and

WHEREAS, the Township of West Milford, pursuant to N.J.S.A.40A:11-11 (6) and N.J.A.C. 5:34-7.29 (c), may, by this resolution and a properly executed purchase order and without advertising for bids, purchase any goods or services from certain approved contract vendors under the Morris County Cooperative Pricing Council, Hunterdon County Educational Services Commission (HCESC), Middlesex Regional Educational Services Commission (MRESC), National Joint Powers Alliance (NJPA), Houston-Galveston Coop and Passaic County Cooperative Pricing System; and,

WHEREAS, the Township of West Milford has the need on a timely basis to purchase goods or services utilizing State Division of Purchase contracts, Morris County Cooperative Pricing Council (MCCPC), Hunterdon County Educational Services Commission (HCESC), Middlesex Regional Educational Services Commission (MRESC), National Joint Powers Alliance (NJPA), Houston-Galveston Coop and Passaic County Cooperative Pricing System from January 1, 2017 to December 31, 2017; and

WHEREAS, pursuant to N.J.A.C. 5:30-5.5 (b), no contract amount shall be chargeable or certified until such time as the goods or services are ordered or otherwise called for prior to placing the order and a certification of availability of funds is made by the Chief Financial Officer; and

WHEREAS, the Township of West Milford can enter into contracts with the attached State and Cooperative Pricing Systems that may have an aggregate over the Township threshold of \$17,500.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of West Milford, County of Passaic, State of New Jersey that the Township of West Milford is hereby authorized to participate in the State of New Jersey Division of Purchase and Property, the Morris County Cooperative Pricing Council (MCCPC), Hunterdon County Educational Services Commission (HCESC), Middlesex Regional Educational Services Commission (MRESC), National Joint Powers Alliance (NJPA), Houston-Galveston Coop and Passaic County Cooperative Pricing System; using vendors on attached list and that the duration of the contracts referenced herein shall be from January 1, 2017 to December 31, 2017.
