Discussion Items / Official Communication

1.	Discussion: High Speed Internet Accessibility: Councilwoman Erik said they should move forward and support this completely. Councilwoman Pegel asked for an explanation for the public. Administrator Senande said this would be a resolution asking the Board of Public Utilities to require all providers to provide 100% coverage in all municipalities. He noted that some less populated portions of the State do not get coverage by the providers. Mayor Dale explained that regardless of whether or not there is enough of the user base, it doesn't mean that the residents should be excluded from the providing coverage. The Council gave consensus to support this.
2.	Discussion: Noise Ordinance: Mr. Semrau provided an overview of the State's noise ordinance. To make changes to have a current ordinance, they will need approval from the State. He will provide a redline version of where the changes would be. Councilwoman Pegel wants to discuss the State requirements at the next meeting. She wants to see the difference between the ordinance now and what the State requires. Councilwoman Erik asked if the draft complies with the State and Mr. Semrau said yes. Mr. Semrau noted that he will walk the Governing Body through the redlined version. Mayor Dale said Administration will provide the redlined version for discussion at a future meeting.

BE IT ORDAINED by the Municipal Council of the Township of West Milford, County of Passaic, State of New Jersey, as follows:

§ 135-2 Department of Community Services and Recreation.

- E. Use of teen center/coffee house.

Each event shall require a security deposit of \$200.

- **SECTION 2.** All ordinances of the Township of West Milford, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.
- **SECTION 3.** If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.
- **SECTION 4.** This Ordinance shall take effect immediately upon final passage, approval, and publication as required by law.
- **SECTION 5.** This Ordinance may be renumbered for codification purposes.

ORDINANCE OF THE TOWNSHIP OF WEST MILFORD, COUNTY OF PASSAIC, STATE OF NEW JERSEY APPROVING THE FINANCIAL AGREEMENT FOR SHOPPING PLAZA URBAN RENEWAL, LLC, LOCATED AT BLOCK 6701, LOT 10, 1938 UNION VALLEY ROAD, IN ACCORDANCE WITH THE NEW JERSEY LONG TERM TAX EXEMPTION LAW OF 1992

WHEREAS, the Township Council, via Resolution 2020-136 adopted March 4, 2020, determined the area of 1926-1938 Union Valley Road ("Redevelopment Area") to be an area in need of redevelopment without condemnation and directed J. Caldwell & Associates, LLC, to prepare a redevelopment plan, and

WHEREAS, J. Caldwell & Associates, LLC prepared a redevelopment plan for the area in need titled "Redevelopment Plan 1938 Union Valley Road Block 6701, Lot 10" (the "Redevelopment Plan"), dated April 16, 2020, and, after review of the Redevelopment Plan at a public meeting held on April 22, 2020, the Mayor and Township Council introduced Ordinance 2020-009 for the implementation of the Redevelopment Plan; and

WHEREAS, on May 20, 2020, Ordinance 2020-009 was adopted by the Township Council implementing the Redevelopment Plan; and

WHEREAS, the Township and West Milford Shopping Plaza Urban Renewal, LLC (the "Entity") have agreed to enter into a Redevelopment Agreement (the "Redevelopment Agreement"), pursuant to which, among other things, the Entity agreed to undertake the redevelopment of the Redevelopment Area to renovate an existing 105,000 square foot shopping center (collectively, the "Project"); and

WHEREAS, pursuant to and in accordance with the provisions of the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 *et seq.* (the "Act") and the Long Term Tax Exemption Law, the Township is authorized to provide for a tax exemption within a redevelopment area and for payments in lieu of taxes; and

WHEREAS, in order to enhance the economic viability of and opportunity for a successful project, the Township will enter into a Financial Agreement with the Entity governing the payments made to the Township in lieu of taxes on the Project pursuant to the Long Term Tax Exemption Law and the Act; and

WHEREAS, in accordance with the Long Term Tax Exemption Law, the Entity filed an application, which is incorporated into the Financial Agreement by reference (the "Application"), with the Township for approval of a long term tax exemption for the Improvements; and

WHEREAS, upon review of the Application, the Township has made the following findings:

A. Relative Benefits of the Project: The Project will provide the Township with an improved ratable where a vacant shopping plaza currently sits. The Redevelopment Area is currently underutilized and could benefit from an upgrade that generates revenues and creates jobs. The Project is expected to produce temporary construction jobs and new permanent jobs.

B. Assessment of the importance of the tax exemption in obtaining development of the Project and influencing the locational decisions of probable occupants: The Entity is making a significant equity contribution toward the cost of the Project. In order to improve the economic viability of the development of the Project, the Township has agreed to provide the tax exemption for the Project pursuant to the Financial Agreement. The stability and predictability of the Annual Service Charge (as defined herein) will make the Project more competitive and assist the Entity to undertake the Project in the Township.

THEREFORE, BE IT ORDAINED by the Township Council of the Township of West Milford, County of Passaic, State of New Jersey:

- **SECTION 1.** The Mayor and Township Administrator are authorized to execute the Financial Agreement on file in the Township Clerk's Office.
- **SECTION 2.** The Township Clerk is hereby authorized and directed, upon execution of the Financial Agreement by the Mayor, to attest to the signature of the Mayor and to affix the corporate seal of the Township upon such document.
- **SECTION 3.** The executed copy of the Financial Agreement shall be certified and filed with the Township Clerk.
- The Mayor and the Township Clerk are hereby authorized to take such action and execute such other documents, on behalf of the Township, as is necessary to effectuate the purpose of this Ordinance and the terms of the Financial Agreement, as deemed advisable by the Township Attorney.
- **SECTION 5.** If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to such section, paragraph, subdivision, clause or provision and the remainder of this Ordinance shall be deemed valid and effective.
- **SECTION 6.** This Ordinance shall take effect upon adoption and passage.

All other full-time employees listed in this ordinance if not otherwise eligible for overtime compensation by contract or law, shall receive 21 compensatory hours annually, plus one half hour for each hour worked above thirty-five or forty hours per week depending on the applicable contract for the employee's department. Vacation and compensatory time may be used or accumulated as follows: vacation days may be carried for up to one year from January 1 following the year earned, and compensatory hours may be taken no later than April 1 of the year following the year earned.
- 4. Stipend Positions will not be subject to increases unless specifically authorized by Resolution of the Governing Body.
- 5. Any ordinance or parts thereof in conflict or inconsistent with the provisions of this ordinance are hereby repealed to such extent as they are in conflict or inconsistent. This ordinance shall take effect 20 days after its final passage by the Township Council.
