1.	Discussion: Assessment on Stowaway Bridge: Administrator Senande provided an update. He mentioned the two resolutions that are on the agenda. He received approval from 20 out of the 21 residents. He said the residents will pay for the bridge and the Township is just assisting the residents with the financing. There is no cost to the Township.
2.	Discussion: 4G/5G Safety Studies – Small Cell Wireless Antennas: Councilman Gross expressed that this will be the most intrusive thing they will ever experience. He said there should be a way to get 5G to provide a way to isolate a house; it comes into your house and stays there without sharing information. It will get to the point where people will have no privacy. Councilwoman Pegel said they need to wait for the direction of other municipalities. The Council agreed to wait for the direction of other municipalities.
3.	Discussion: Town-wide Garage Sale (September 18, 19 & 20): The Council agreed to proceed with the garage sale.
4.	Outdoor Dining: Councilman Goodsir asked if the Council could pass a resolution and/or ordinance to continue outdoor dining. Mayor Dale said yes and she noted that she did speak with Mr. Semrau about this. She explained that if a business has an outdoor area that was fenced off because of Covid-19 and normally not allowed to serve alcohol in that area, the Council would like to continue to allow those businesses to serve in those designated areas on an ongoing basis. Mr. Semrau noted that the business would have to file for an expansion of license premises and have it approved by the Council. Mayor Dale said they should put something together to assist the businesses in filing. She expressed that there is more to consider and they have to review the premises.

ORDINANCE OF THE TOWNHSHIP OF WEST MILFORD, COUNTY OF PASSAIC, STATE OF NEW JERSEY AMENDING AND SUPPLEMENTING CHAPTER 10, TRAFFIC, SECTION 10-3 PARKING SCHEDULE I NO PARKING, OF THE REVISED GENERAL ORDINANCES TO PROHIBIT PARKING AT ANY TIME ALONG OTTERHOLE ROAD

BE IT ORDAINED, by the Township Council of the Township of West Milford, in the County of Passaic and State of New Jersey, as follows:

SECTION 1. Chapter 10, Traffic, Section 10-3, Parking, Schedule I, is hereby amended in regard to prohibited parking at any time along the following street or portion thereof as follows:

NAME OF STREET	SIDE	<u>LOCATION</u>
Otterhole Road	West Side	From the intersection of Weaver Road Southerly to the Bloomingdale Line.
	East Side	From a point 1100 feet North of the Bloomingdale Line to opposite Weaver Road

- **SECTION 2.** Regulatory signs shall be erected to affect the above designated No Parking Zone.
- **SECTION 3.** If any section or provision of this Ordinance shall be held invalid in any Court of competent jurisdiction, the same shall not affect the other section or provisions of this Ordinance, except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.
- **SECTION 4.** All ordinances of the Township of West Milford which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.
- **SECTION 5.** If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

WHEREAS, R.S. 52:27BB-34 authorizes the Local Finance Board of the State of New Jersey to prescribe reports pertaining to the local fiscal affairs; and

WHEREAS, the Local Finance Board has promulgated N.J.A.C. 5:30-6.5, a regulation requiring that the governing body of each municipality shall, by resolution, certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled "Comments and Recommendations"; and

WHEREAS, the members of the Governing Body have personally reviewed, as a minimum, the Annual Report of Audit, and specifically the sections of the Annual Audit entitled "Comments and Recommendations", as evidenced by the group affidavit form of the governing body attached hereto; and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52, to wit:

R.S. 52:27BB-52: A local officer or member of a local governing body whom, after a date fixed for compliance, fails or refuses to obey an order of the director (Direct of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office.

Reports of Administrator, Mayor and Council Members

<u>Mayor Dale</u> – Noted there will be a September 11th Memorial Service at the Monument at 7 pm. She explained that the Township is developing a sustainable economic development plan and there is a survey on the Township website for residents and businesses. She mentioned that the Highlands Market will not open on September 4th. It will be opening some time near September 15th.

<u>Councilwoman Gerst</u> – Expressed that most of the zoning regulations are based on one acre lots. She explained that residents who live in the lake communities have to go to the Zoning Board, put money in escrow and get a variance for something as simple as a shed. She noted that it is very inconvenient because there are many homes in West Milford that are not on one acre lots.

Discussion:

Mayor Dale asked Mr. Semrau how they should address the zoning issue that Councilwoman Gerst is concerned about. Mr. Semrau said he would consult with the Township Planner, Jessica Caldwell. Mayor Dale said this is long overdue and it will help the Township in an Administrative aspect and will also benefit the residents. Councilman Gross asked if they can revise the ordinance with exceptions based on property size. Mr. Semrau said he will look into that. The Council gave consensus for Mr. Semrau to consult with the Township Planner. Mayor Dale said she would like to see this accomplished before the end of the year. Councilwoman Erik explained that in Ringwood, they provide a package to the residents guiding them through the permit process. She feels that the Township needs a package like Ringwood. Mayor Dale expressed that they are working on creating the efficiency and the process flow that they should have as a municipality when residents come to get a permit. There is a lot of focus on this and it will take some time.

Councilwoman Pegel - No report.

Councilwoman Lichtenberg – Noted various events and the dates and times. She said the Highlands Family Success Center moved to 1801 Greenwood Lake Turnpike.
