Robert Brady, Board Chairman, opened the Regular Meeting of the Zoning Board of Adjustment at 7:10 p.m. The Board Secretary read the Legal Notice. The Pledge of Allegiance was recited.

Due to the fact that this was a special meeting conducted at the West Milford High School Auditorium to accommodate the size of the public attending, a Court Reporter was obtained for the purposes of providing a transcript. Stoppiello, License number XIO1163, a Certified Court Reporter and Notary Public of the State of New Jersey and is available by request in the Planning Department.

The applicant was represented by Robert Landel from the law firm of Landel, Bernstein & Kalosieh who was filling in for attorney Robert Tafuri, Esq. of the law firm of Sunshine, Atkins, Minassian Tafuri, D'Amato & Beane, P.A. Susan Rubright, Esq. of the law firm of Brach Eichler was present representing A Clean West Milford, an interested public resident group. The applicant presented the testimony of Kevin Boswell, a licensed professional engineer who testified in detail regarding all aspects of the site plan and engineering concerns regarding said plan. As stated aforesaid, an official certified transcript of his testimony has been obtained and on file with the Planning Department and is incorporated herein as if set forth at length.

Additionally, the applicant presented the testimony of Frank Rossi who testified in detail regarding the Environment Impact Statement (EIS) and related environmental issues. He is employed by Boswell Engineering as head of their Environmental Division. He is a licensed Engineer and a licensed site remediation professional in the State of New Jersey. As previously indicated an official certified transcript of his testimony has been obtained and on file with the Planning Department and is incorporated herein as if set forth at length.

Attorney Rubright had an opportunity to partially cross-examine the aforesaid witnesses. She agreed to allow members of the public to be heard before she completed her cross-examination.

The Board heard from the following members of the public: Jessica Keough, Justine Drew, Troy Osborne, Kathryn Olinger, Gary Paolazzi. Their remarks, concerns and complete testimony is also included in the official transcript and adopted and incorporated herein as if set forth at length.

The matter was carried to a Special Meeting to be held on October 15, 2019 in order to continue with the application and afford the applicant as well as members of the public additional time in which to present their respective positions.

The Public portion of the meeting ended at 11:00 PM.
