The County is not responsible for undelivered bid proposals or bid proposals otherwise not arriving on time. Pursuant to <u>N.J.S.A.</u> 40A:11-13.2, the County reserves the right to reject bid proposals for the reasons stated therein.

The County of Passaic is a regional government comprised of sixteen municipalities in northern New Jersey. The County is seeking qualified organizations or agencies in accordance with the scope of work specified in this request for services to provide Youth Empowerment and Wellness Program for Middle and or high school age students (grades 6-12), including those at risk of academic failure, mental health challenges, or socio-economic difficulties.
