INSTRUCTIONS FOR VOTING

- 1. To vote for a candidate, press the button \square under the person's name. A green "X" will appear next to your selection.
- 2. To change a selection, press the button \square again. The green "X" will disappear and you may make a new selection.
- 3. If you wish to cast a write-in vote, go to the PERSONAL CHOICE row and press the button below "Write In" in the same column as the office you wish to write-in. Using the alphabetical keyboard below, enter the name of the person of your choice, one letter at a time. To make a space between the first and middle name or initial and last name, use the arrow pointing to the right on the keyboard. To make a correction, use the arrow pointing to the left. The name you enter will appear in the display to the left of the keyboard. Prior to pressing enter for a write-in vote, be sure you have verified the spelling of the person's name and you have selected the correct office. Your choice is recorded and removed from the display.

WARNING: If instructions for a write-in vote are not followed exactly, then you have an improperly cast write-in vote, which will be void and not counted.

- 4. After ALL selections have been made, press the RED CAST VOTE BUTTON located at the bottom right. This electronically records all of your votes.
