

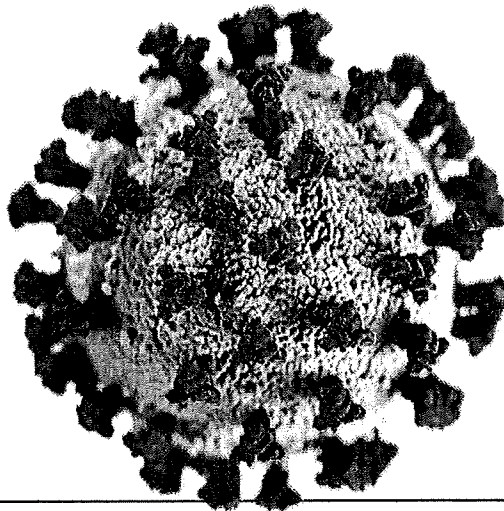

August 11, 2021)



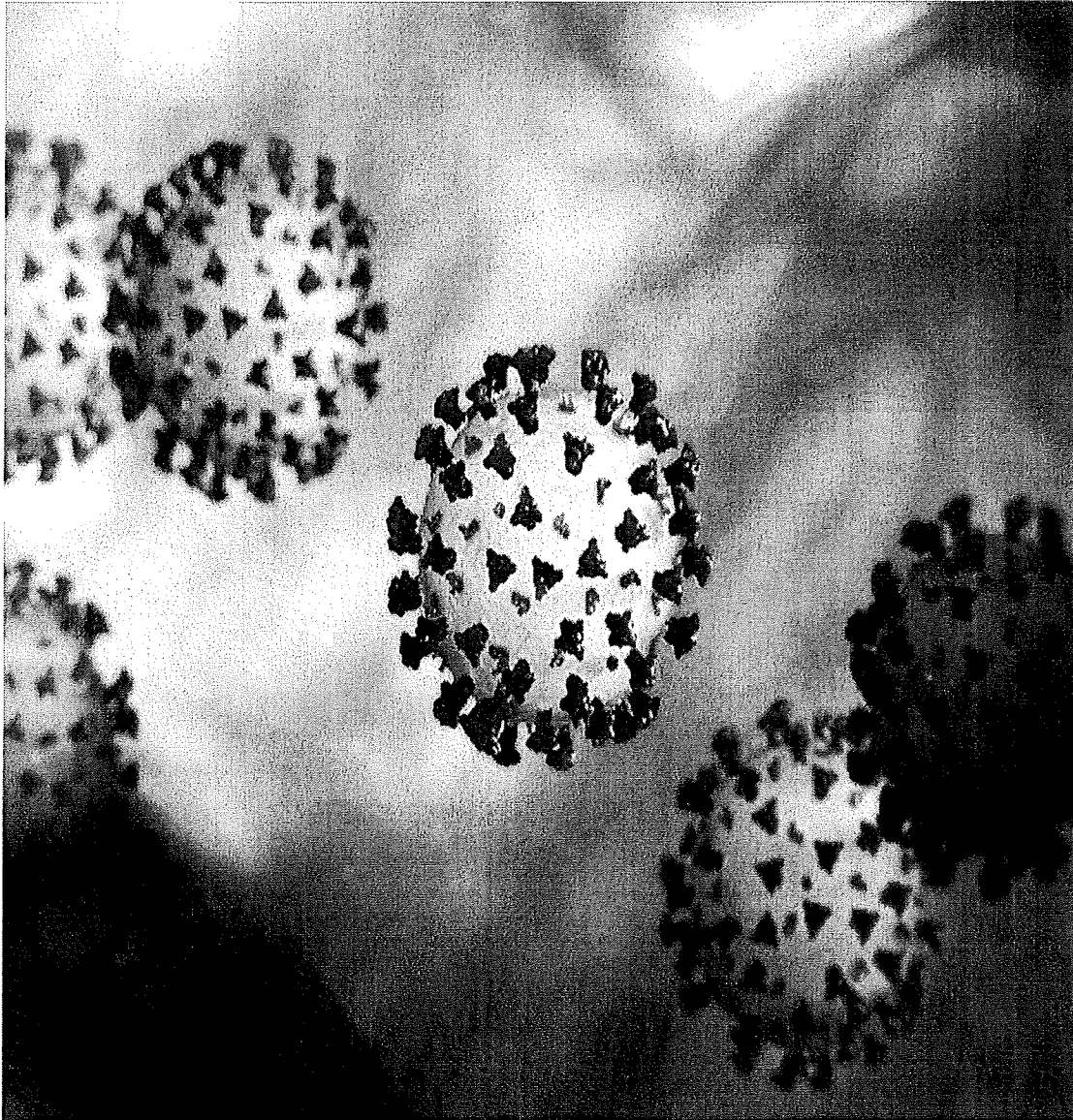

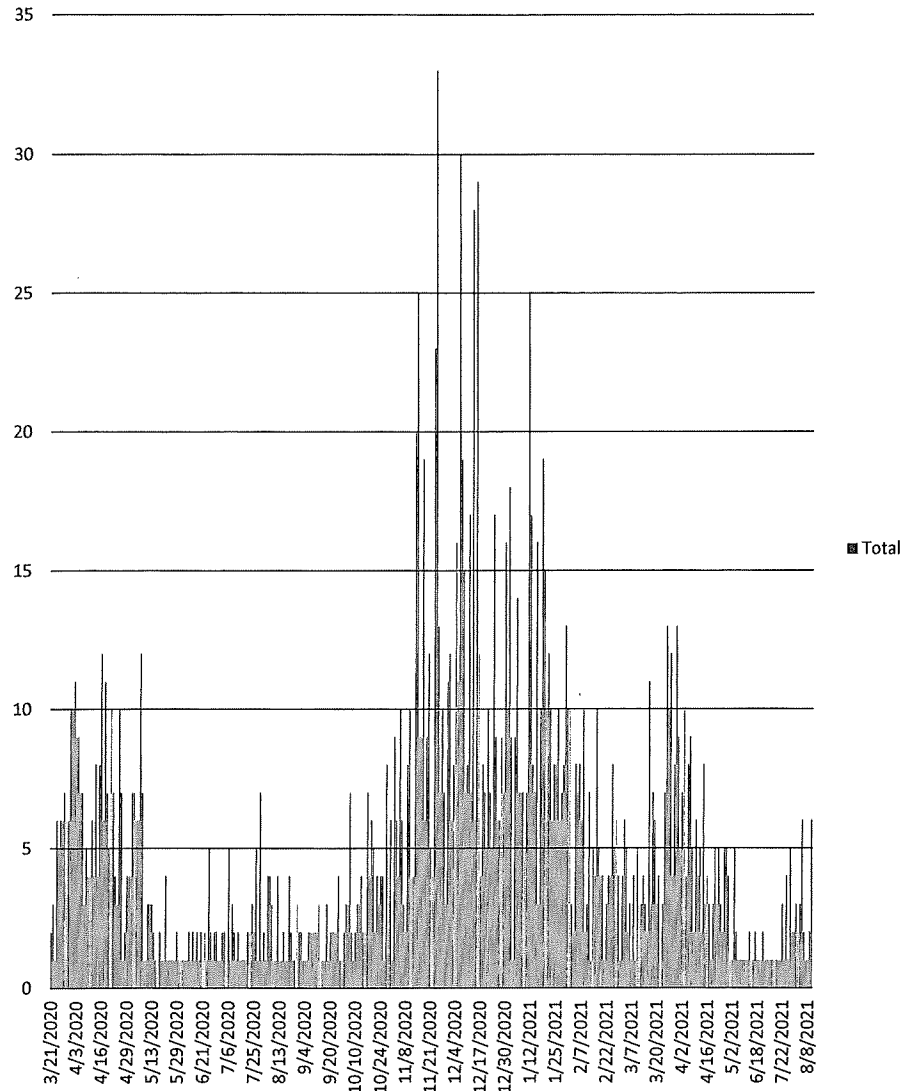

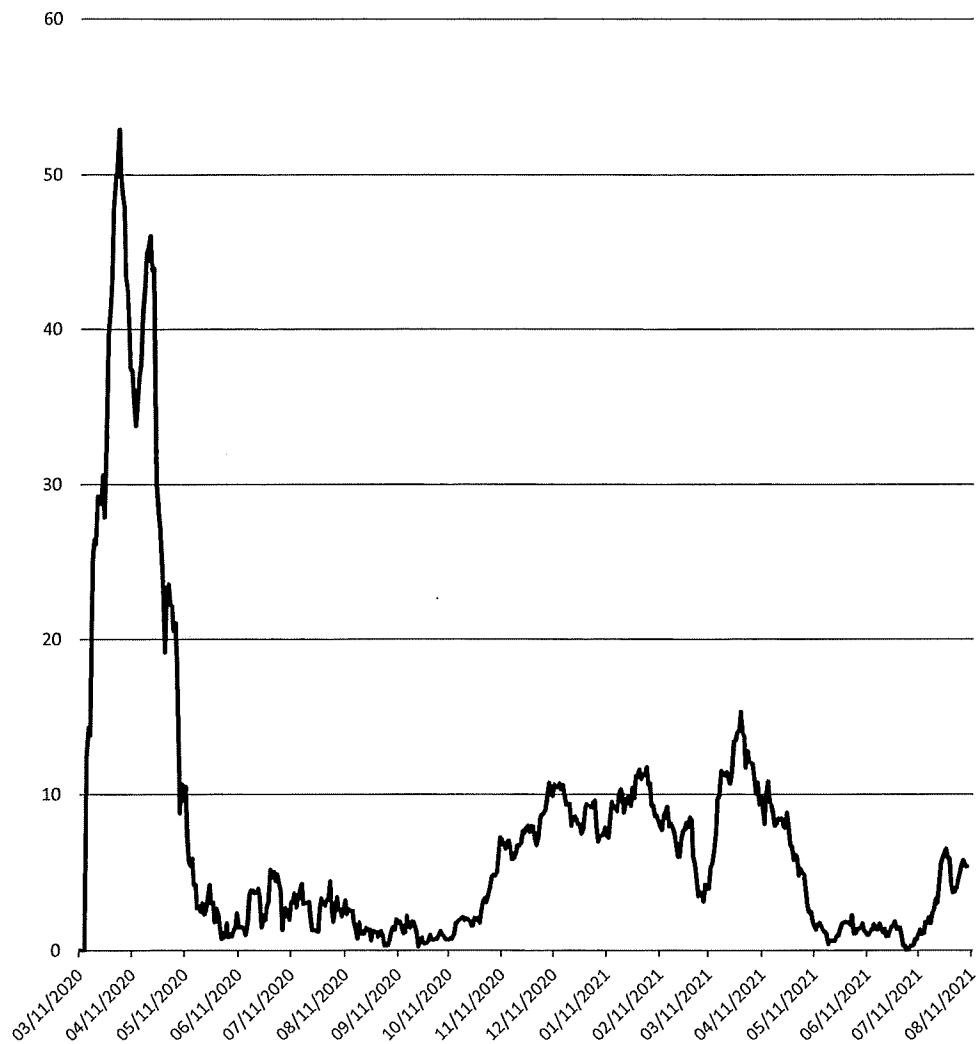

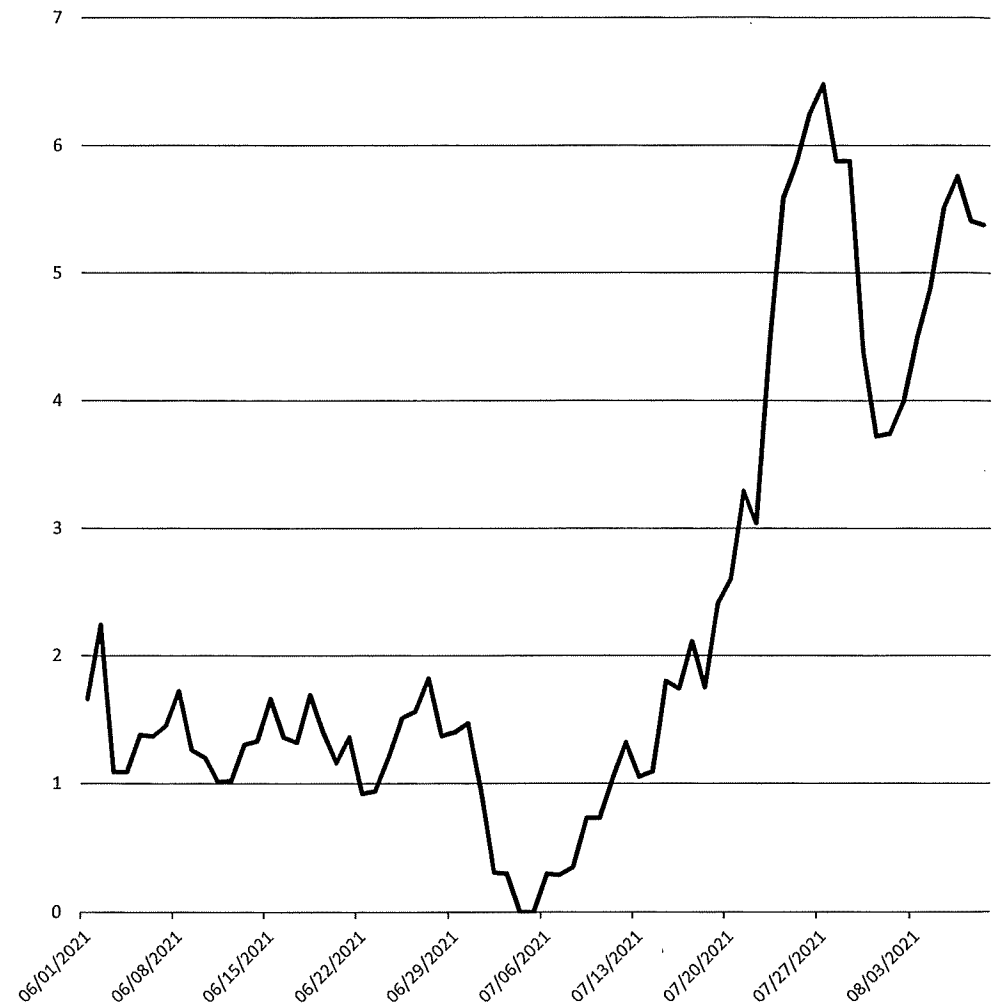
West Milford Epidemic Curve as of 8/11/2021



West Milford Percent Positivity as of August 11, 2021 (7 Day Average)

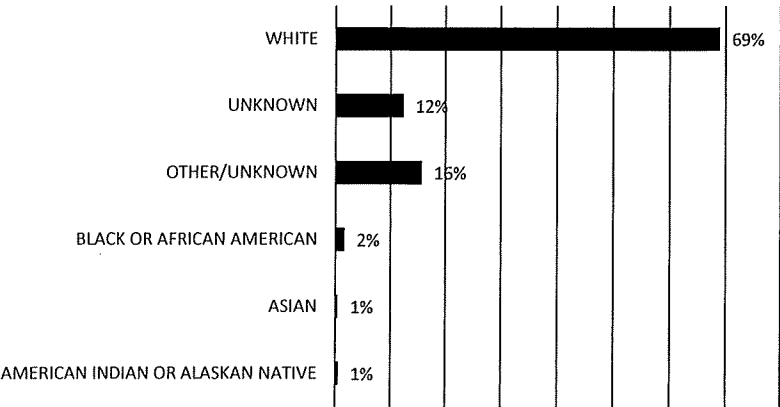


West Milford Percent Positivity for June 1, 2021- August 11, 2021 (7 Day Average)

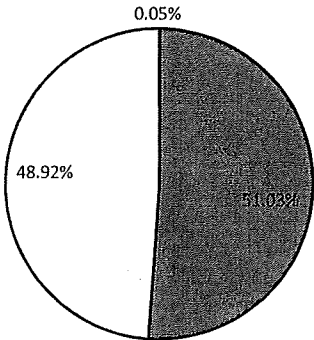


West Milford COVID-19 Cases by Race/Ethnicity, Gender, and Age as of 8/11/2021

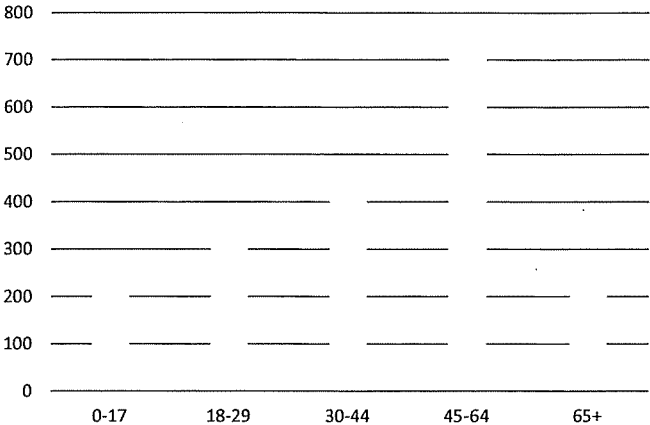

West Milford COVID-19 Cases by Gender

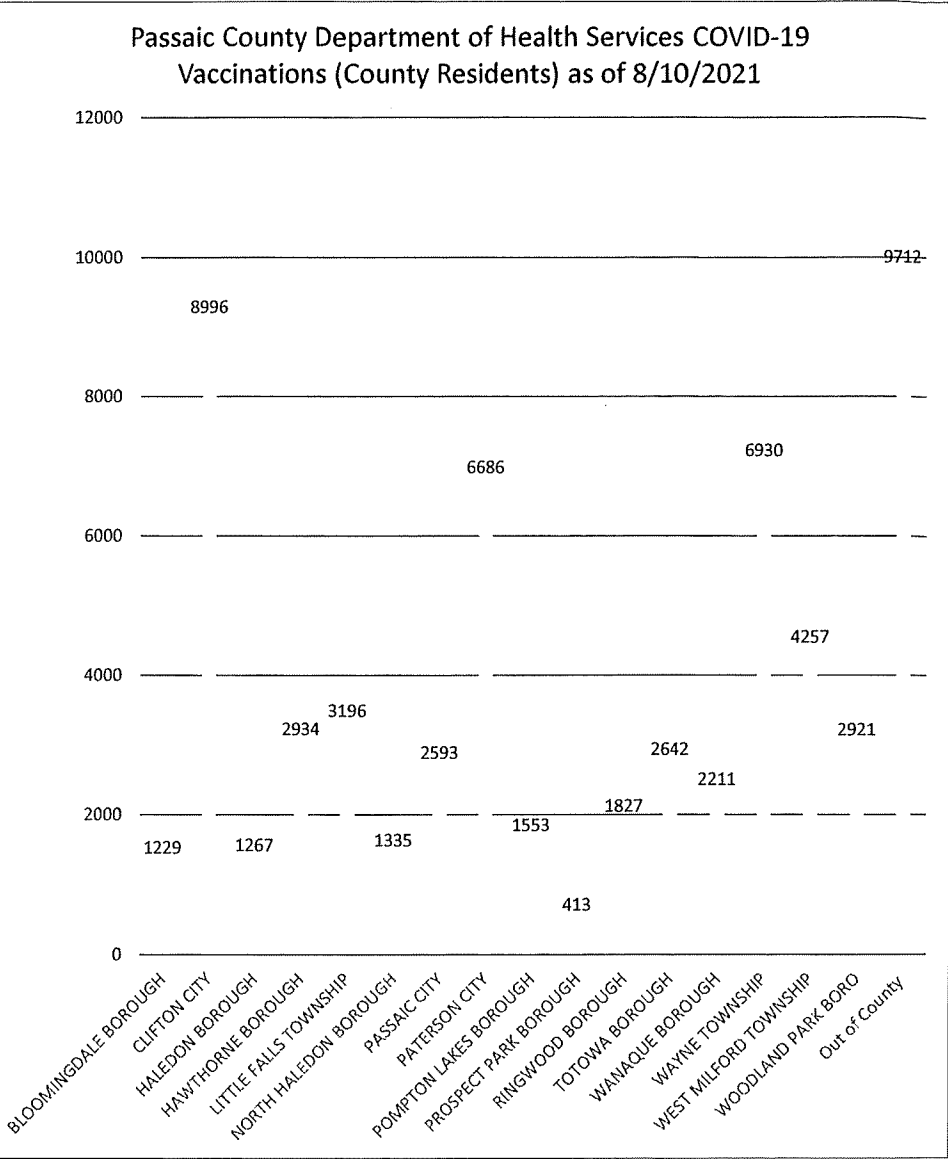


West Milford COVID-19 Cases by Age

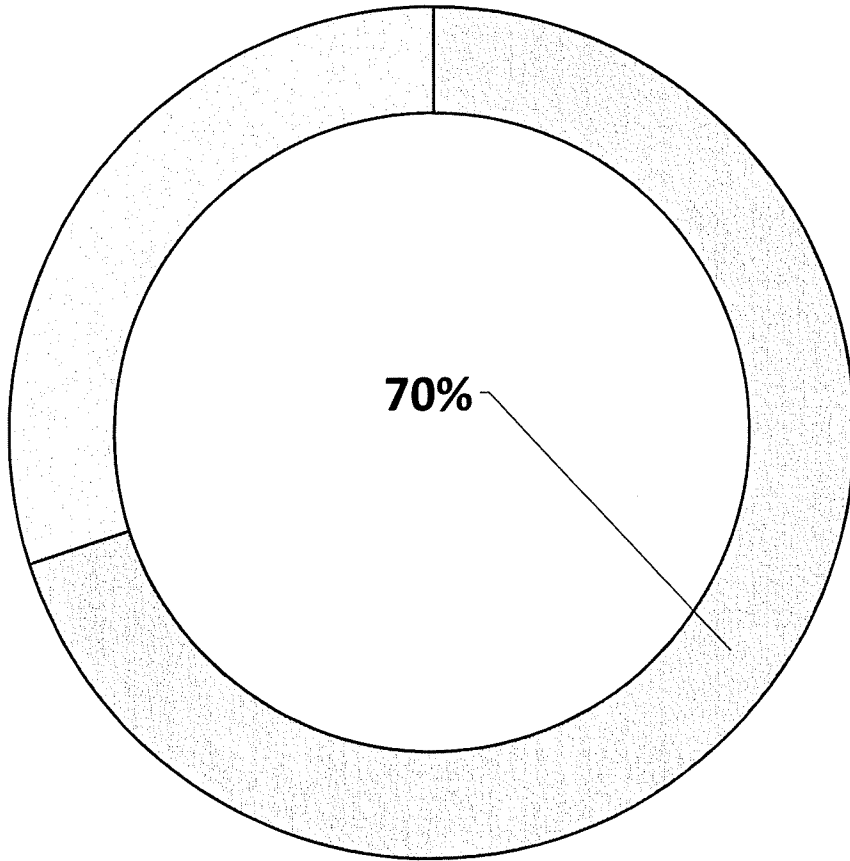

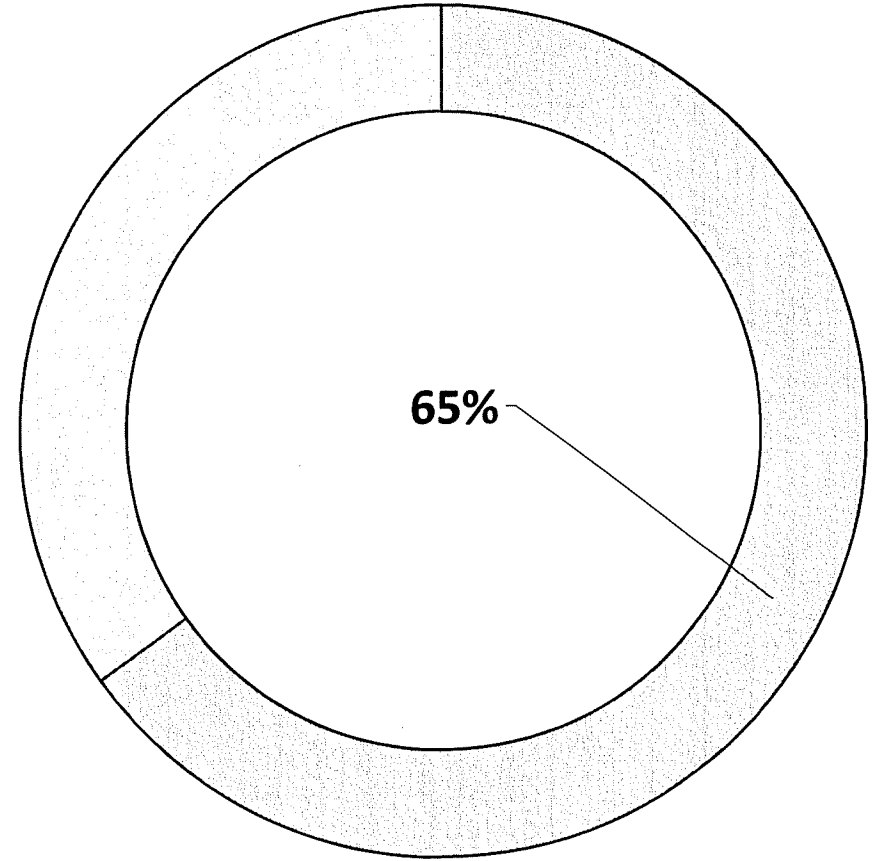

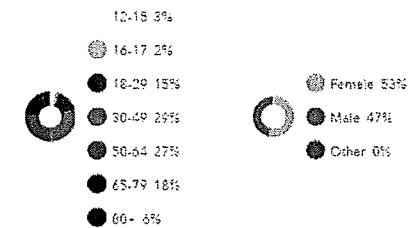
Vaccinations Reported by New Jersey Sites*

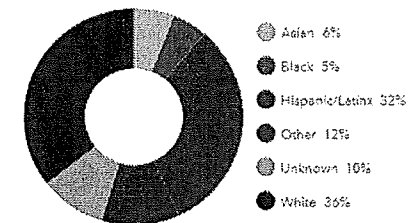
People with at least one vaccine dose†

Delta Variant (B.1.617.2)

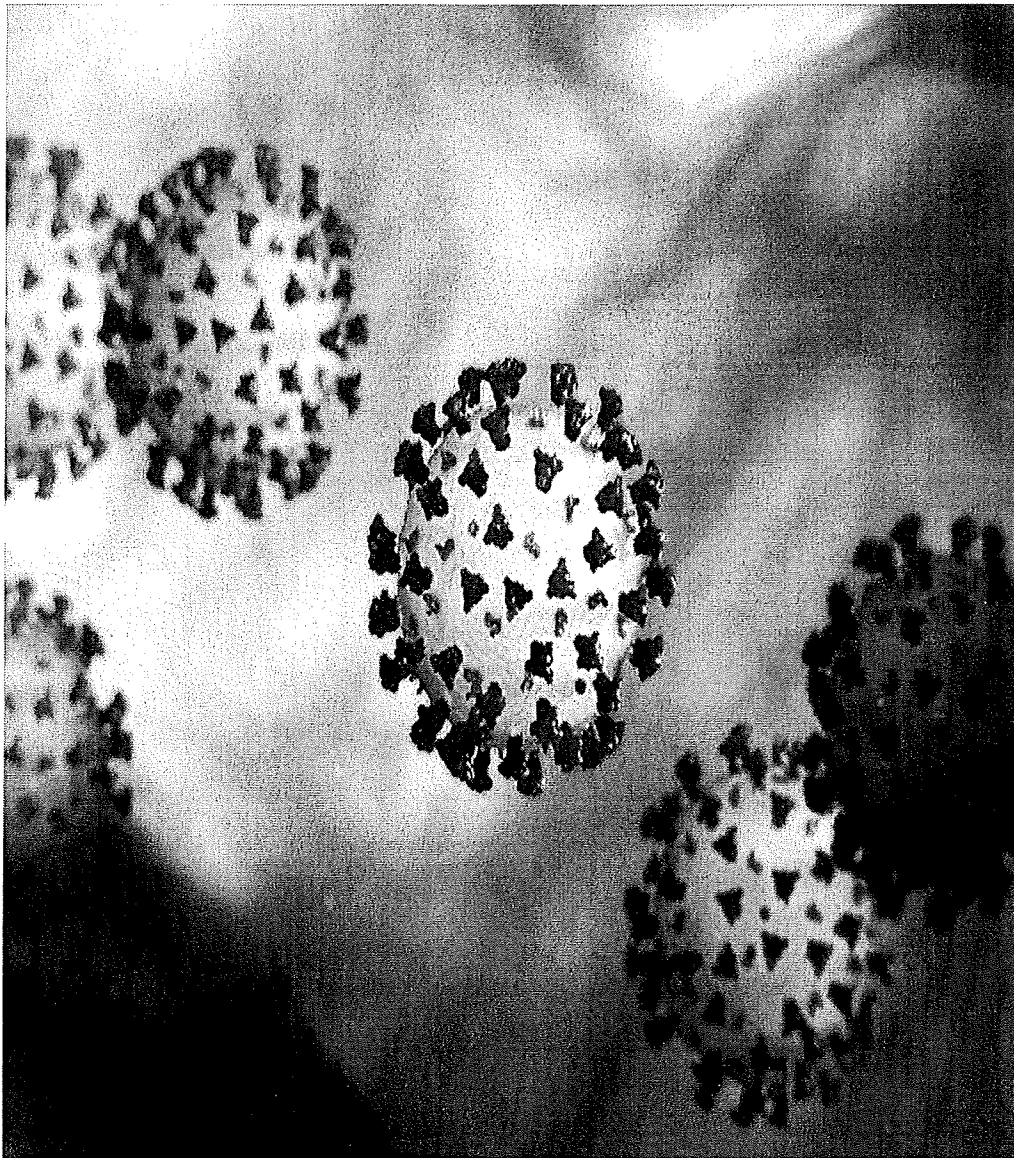
- Very Virulent
 - Much more contagious and deadly than the original strains of COVID-19
 - Vaccine remains highly effective against severe illness and death
- 90% Of Specimens Sequenced By NJPHEL Are Delta Variant Strain
- Backlog Of Reports In CDRSS
- Breakthrough Cases
 - Fully vaccinated, yet test positive
 - A NJDOH June report identified 1,319 COVID-19 breakthrough cases which represents 0.06% of those vaccinated
- CDC Recommendations for Fully Vaccinated People
 - Fully vaccinated people wear a mask in public indoor settings in areas of substantial or high transmission
 - Fully vaccinated people might choose to wear a mask regardless of the level of transmission, particularly if they are immunocompromised or at increased risk for severe disease from COVID-19, or if they have someone in their household who is immunocompromised, at increased risk of severe disease, or not fully vaccinated
 - Fully vaccinated people who have come into close contact with someone with suspected or confirmed COVID-19 to be tested 3-5 days after exposure, and to wear a mask in public indoor settings for 14 days or until they receive a negative test result*
- Masking Requirement for 2021-2022 School Year
 - All students, educators, staff, and visitors will be required to wear face masks indoors

COVID-19 Related Updates

- >70% of adults are now fully vaccinated in Passaic County
- NJ DOH Ambassador Program
 - Shop Rite Clinic, in partnership with North Hudson and Passaic City Health Department (81 Vaccinated)
 - Passaic County Fair
- Docket App
 - Direct access to personal and family immunization records
 - App Store
- Hospitalizations
 - More than doubled statewide in just 3 weeks (696 today)
 - Primarily unvaccinated patients
 - Nationwide, the majority (81.4%) of counties with high COVID-19 incident rates are found in communities with low vaccination coverage
- Passaic County Case Increase
 - Overall performing better than other counties (i.e., Bergen County and Monmouth County)
- On August 6, 2021, Governor Murphy signed Executive Order 252
 - All workers in certain state and private health care facilities and high-risk congregate settings must be fully vaccinated against COVID-19 by 9/7/2021 or be subjected to COVID-19 testing a minimum of 1-2 times/week
 - E.g., County and State correctional facilities, LTC facilities
- Janssen Shelf Extension
 - The FDA authorized an extension of the shelf life for the Johnson & Johnson's Janssen COVID-19 vaccine from 4.5 months to 6 months (an additional 45 days)
 - Decision based on data from ongoing stability assessment studies, which have demonstrated that the vaccine is stable at 6 months when refrigerated at temperatures of 36 – 46 degrees Fahrenheit

Step 1: Make Your Appointment

If you are eligible to receive a vaccine:

- Register for the vaccine on the [NJ Vaccine Scheduling System](#), and you will be notified when an appointment is available to you. Call 1-855-568-0545 if you need assistance.
- OR, make an appointment directly with one of the designated [vaccine sites](#).

Please be patient. Supplies are limited and it may take some time to set up your appointment. Eventually everyone who wants it will receive the vaccine!



Step 2: Get Vaccinated

When you get your vaccine, you will receive the following:

- Information about the vaccine you are receiving
- Monitoring for 15-30 minutes to make sure you have no immediate side effects
- A card that lists the vaccine name, date, location, and when to receive your second dose. Make your second dose appointment at the site where you received your first dose!



Step 3: Stay Healthy

Stopping a pandemic requires using all the tools we have available. Know that it takes time for your body to build protection after any vaccination, so it is important that you continue wearing a mask, practicing physical distancing, washing your hands frequently, and staying home when sick.
