> for West Milford. 162 have been completed for West Milford. For Environmental Health the Chief REHS reports that from August 2023 to December of 2023, there have been 53 food inspections and there were 8 re-inspections, reviewing 2 mobile events and 49 temporary events. There have been 113 OPRA requests and 26 public health nuisances investigated as well as various other inspections, and those for septic and wells. Sandy Cameron is the Public Health Nurse Supervisor for communicable disease and nursing and shared some upcoming events on the calendar. We are celebrating Heart Health Awareness Month here at Town Hall on February 16 from 12 to 3 p.m. There will be heart health information given out and chair yoga. February 26 to March 1 is shingles awareness week. Those residents wishing to receive the shingles vaccine must be uninsured. The clinic is the Adult 317 Clinic and residents can get any of the vaccines we offer. We need to get the word out to residents. Ms. Cameron gave one shingles shot and one flu shot last month. Coming up on June 22, 2024, Hype for Hope which concerns mental health awareness. The Well Child Clinic will take place next Wednesday February 21 for children with no insurance. Health insurance providers will be available to sign families up. Currently the law is that any child, documented or not, may sign up for the NJ Family Care Plan A and see a pediatrician and get the medical help they need. March 15 there will be a free Covid 19 and flu clinic, with the new 2023-2024 vaccine formula. That clinic will be open to everyone from 12 p.m. to 3 p.m. at Town Hall. Mayor Dale indicated that the schools have received the survey as well, in order to get the requested feedback.

ORDINANCE OF THE TOWNSHIP OF WEST MILFORD, COUNTY OF PASSAIC, STATE OF NEW JERSEY CONCERNING SALARIES AND COMPENSATION FOR SPECIAL POLICE OFFICERS

BE IT ORDAINED by the Township Council of the Township of West Milford, County of Passaic, State of New Jersey that pursuant to Chapter 33 entitled Personnel of the Revised General Ordinances of the Township of West Milford, New Jersey, 2007 the following Officers and Employees here below stated shall be classified by job title with the corresponding pay ranges:

- 2. CLOTHING ALLOWANCE Special Officers qualify for a clothing and maintenance allowance annually. Half the annual amount payable on or about December 1st of each year for those officers working a minimal of 35 hours since January 1st of that year, with an additional payment of \$2.50 each hour worked in addition to the minimum 35, with the total allowance not exceeding the maximum amount for that year regardless of the number of all hours worked. Special Officers qualifying for a clothing and maintenance allowance upon the submission for receipts for actual purchases of up to \$410.00.
- 3. HOLIDAY PAY Officers shall be entitled to time and one-half pay for all hours worked on New Year's Day, Easter, Memorial Day, July 4th, Labor Day and December 25.
- 4. CALL-OUTS All callouts are payable for time worked, with a minimum of three hours pay including mandatory training.
- 5. Township Road Work Callouts payable by normal hourly wage.
- 6. Contractor Road Work Callouts payable at \$30.00 per hour.
- 7. GENERAL PROVISIONS Any ordinance or parts thereof in conflict or inconsistent with the provisions of this ordinance are hereby repealed to such extent as they are in conflict or inconsistent.

ORDINANCE OF THE TOWNSHIP OF WEST MILFORD, COUNTY OF PASSAIC, STATE OF NEW JERSEY AMENDING AND SUPPLEMENTING CHAPTER 271, "POLICE SERVICES CHARGES," OF THE REVISED GENERAL ORDINANCES

BE IT ORDAINED by the Township Council of the Township of West Milford, County of Passaic, State of New Jersey, as follows:

SECTION 1. Chapter 271 Police Services Charges, Section §271-2, Rate for employment by third parties, of the Revised General Ordinances of the Township of West Milford, is hereby amended and supplemented to read as follows:

§ 271-2. Rate for employment by third parties.

Third parties seeking to utilize Township police services must coordinate the services through the Police Department. The Township shall be paid for the outside employment of police by third parties at a rate equal to the overtime rate of the officer being employed or the average overtime rate as of January 1st of that year, whichever is greater. Special Police Officers shall be paid at their straight time rate. An additional 10% shall be added for benefits, supervision, and other overhead. The Township may require the establishment of an escrow account initially funded at an amount estimated to cover the cost of the employment, which shall be posted at least 10 days prior to the date in which the employment is needed.

- **SECTION 2.** All ordinances of the Township of West Milford which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.
- **SECTION 3.** If any section, subsection, clause or phrase of this ordinance is for any reason held to be unconstitutional or invalid by any court or competent jurisdiction, such decision shall not affect the remaining portion of this ordinance.
- **SECTION 4.** This Ordinance may be renumbered for purposes of codification.

SECTION 5. EFFECTIVE DATE – This ordinance shall take effect on April 1, 2024.

ORDINANCE READOPTING ORDINANCE 2003-02 TO VACATE CERTAIN PUBLIC RIGHTS IN A ROAD KNOWN AS "TENAFLY COURT" OF THE TOWNSHIP OF WEST MILFORD, COUNTY OF PASSAIC, STATE OF NEW JERSEY

WHEREAS, Ordinance 2003-02 has been previously adopted and enacted into law and duly published as the law provides; and

WHEREAS, this Ordinance will readopt Ordinance 2003-02 that previously was omitted in the recording with the Passaic County Clerk; and

WHEREAS, a recent pending real property sale recognized that Tenafly Court was omitted from the Passaic County Clerk records and is needed for the real property sale to proceed; and

NOW THEREFORE BE IT ORDAINED, by the Township of West Milford Township Council finds that the readopting of Ordinance 2003-02 is as follows:

WHEREAS, Tenafly Court was dedicated to the public by virtue of inclusion on a filed map entitled "Fifth Map of Upper Greenwood Lake" which was filed with the Passaic County Register on August 1932, as Map No. 943; and

WHEREAS, in response to a road assessment petition by residents, the Township Council adopted Ordinance No. 1985-7 on June 19, 1985, accepting the roads surrounding, but not including, Tenafly Court, on the basis of recommendations from the Township Engineer not to accept Tenafly Court because it served no public need; and

WHEREAS, it continues to be the recommendation of the current Township Engineer that Tenafly Court be vacated due to the fact that it serves no foreseeable future public need as a right-away; and

WHEREAS, the Township of West Milford has determined that it wishes to vacate the public interest in Tenafly Court.

NOW, THEREFORE, BE IT ORDAINED, by the Township Council of the Township of West Milford, in the County of Passaic and State of New Jersey, as follows:

- 1. Tenafly Court which was created by the "Fifth Map of Upper Greenwood Lake" which was filed with the Passaic County Register on August 8, 1932, as Map No. 943, shall be vacated.
- 2. That the vacation of the above-described property shall in no way affect any private rights which may exist at the time of passage of this Ordinance.
- 3. That pursuant to law all rights and privileges possessed by any public utility are hereby reserved and exempted from the effects of this Ordinance.
- 4. That a copy of this Ordinance together with a certified copy of the proof of publication shall be filed with the Township Clerk and the proper County office according to law.
- 5. After introduction, this Ordinance shall be referred to the Township Planning Board for review and comment pursuant to N.J.S.A. 40:55D-26, -32 and -33 since it is a vacation.
- 6. If any section or provision of this Ordinance shall be held invalid in any Court of competent jurisdiction, the same shall not affect the other sections or provisions of this Ordinance, except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.
- 7. The introduction of this Ordinance shall be advertised pursuant to N.J.S.A. 40:49-2, provided, however that notice as to introduction and public hearing shall be made, pursuant to N.J.S.A. 40:49-6 at least (10) days prior to the public hearing and adoption hereof.
- 8. Notice of the introduction of this Ordinance and the time and place when and where this Ordinance will be further considered for public hearing and final passage, including a copy of this ordinance, shall be mailed to every person whose lands may be affected by this Ordinance, so far as same may be ascertained, directed to the last known post-office address, in accordance with the provision of N.J.S.A. 40:49-6.
- 9. Within sixty (60) days after adoption of this Ordinance, the Township Clerk shall cause this Ordinance, certified under the seal of the Township, to be filed in the office wherein conveyances of lands are recorded in the County of Passaic.
- All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed to the extent of such inconsistency.
- 11. This Ordinance shall take effect immediately after final passage and publication in the accordance with the laws of the State of New Jersey.

- E. A nonrefundable maintenance fee of \$25 shall be charged for each group use permit that requires the opening, closing and/or cleaning of a facility.
- F. Permit fees: Bubbling Springs Members will be charged a nonrefundable administrative/user fee of \$30 for guest groups numbering 25 or more people. Permits must be filled out at the Parks and Recreation office. Groups of under 25 do not need to have a permit or pay a maintenance fee. They must make arrangements with the Lake Director prior to the party.
- G. Use of Teen Center/Coffee House.

 - (2) \$100 per hour, per gym rental fees to nonlocal not-for-profit organizations based outside the Township of West Milford. Nonprofit organizations are defined as registered organizations under § 501(c)(3) of the Federal Tax Code.
 - (3) \$100 per hour, per gym rental fees to local for-profit organizations upon the issuance of permits and proof of proper insurance has been provided.
 - (4) Concession Stand rental fee: \$75 for three hours and \$25 for each additional hour.
 - (5) Exemptions:
 - (a) Fees will not be assessed to local nonprofit organizations defined in Subsection I (1) if requested use occurs during regular operating hours of the West Milford Recreation Center, as established by the Township of West Milford Department of Community Services.
- I. The Department of Community Services and Recreation is to provide all currently appointed members of boards, committees and commissions established by ordinance a \$5 discount for their own registration for each of the programs and events offered by the Department. All such members shall also be entitled to receive the same rates for Bubbling Springs as is provided to seniors.

Public Comments

Renee Allessio - Is a 46 year resident of West Milford and is interested in three ordinances tonight. One would make the Mayor full-time, another presents compensation range of \$90,000 to \$135,000 for a fulltime Mayor and the other to repeal the Deputy Administrator position. Not long ago the town of Wayne tried to make their Mayor full-time but the public was opposed. She listed towns with larger populations, Paterson and Clifton included. Newark and Jersey City have larger populations, with as many as 310,000 and 290,000 people respectively, and the Mayors' salary is in line with the others. A Town with about 26,000 people shouldn't need a full-time Mayor making the same amount. Most small towns do not have a full-time Mayor. If the Administrator/Clerk needs help then a Deputy Administrator should be hired. Currently the median household income in West Milford is about \$75,000. Should our Mayor make more than what the average resident makes? Ms. Allessio indicated that taxes in the Township are very high, and she questioned where the added money would be coming from, perhaps the new cannabis businesses that were allowed, or perhaps the TGP Compressor station. Ms. Allessio indicated that she finds it interesting that the Mayor was just recently re-elected and now there is an ordinance that would make her full-time. Mayor Dale ran on the platform of being a part-time Mayor and was elected on that premise. Mayor Dale has been a part-time Mayor since 2018 and Ms. Allessio would like to know the reason for the change. It looks like a power grab. She suggested that it should be up to the people to vote in a referendum, not the Council.

Tim La Pointe - Has been in Town for 58 years and has a construction businesses and works all over the Northern portion of the State. He indicated that he takes issue with the restructuring of the Health Department because the Town is getting rid of one of the most consummate professional in the State of New Jersey and replacing them with people who don't have the ability to do the job. Sue Muhaw is one of the best ever at her job. He indicated that he had to work with Ms. Muhaw just today because the people from Passaic County do not know how to get permits through because they don't know what they are reading and they don't know how to look at it. He indicated that the Council needs to rethink this and that it is not about money, it's about common sense. Ms. Muhaw does not even live in the Township but has always worked to protect the Township. Additionally, we have never had a full-time Mayor and we don't need one. If the Administrator can't handle the load, you need to look there because every other Administrator could. There's a problem there. The Council will be questioned if they change the form of government with an ordinance. It should be put to the people for a vote to see who the best candidate is and should not be a politically appointed position.

Laura Ashtyani – Questioned why we would need a full-time Mayor and wondered if there were things that residents didn't know about or need to know about that would require a full-time Mayor. Ms. Ashtyani would like to know what has happened since the Mayor ran on the platform of being a part-time Mayor.

She questioned if it would be possible to have the Administrator or a Deputy Administrator handle the duties that the Mayor would be performing. Who decides on the salary, it seems like this salary is higher than other Mayors in a similar Town setting. Ms. Ashtyani indicated that it should be up for a public referendum and while she's in favor of paying people for what they earn, this seems out of the ordinary and the public would like answers.

James Foodie – Agreed with Mr. La Pointe. He is concerned that if Mr. Senande can't handle the job, he shouldn't be both the Township Administrator and the Township Clerk. The Township Clerk job should go to Ms. Curcio who is certified to be the Clerk. He spoke with former Mayor Bieri who indicated that the Township did not need a full-time Mayor but needed a full-time Administrator and a full-time Clerk. He indicated Mr. Senande should be the Administrator, Ms. Curcio should be the Clerk and if a Deputy Administrator was necessary, that is fine but a full-time Mayor with a salary ranging from \$90,000 to \$135,000 is ridiculous. He referred to some rumors regarding TD Bank and suggested that a referendum was not even necessary just that Mr. Senande should not be both Administrator and Clerk.

Seeing no one else wishing to speak, Councilman Conlon made a motion to close the public portion. Seconded by Councilman Chazukow. All were in favor.

Council Comments

Councilman Conlon - Indicated that with Passaic County taking over the Health Department, the current employees will be given the opportunity to continue to do the job that they are doing now, but just under a different banner, while providing the residents with the same services as well as the employees having additional options that they currently don't have. To prejudge anything at this point is both premature and inappropriate. There will be a benefit for the Township because of the shared service agreement with Passaic County. There will be benefits for the Municipality not only financially but logistically. Councilman Conlon does not appreciate any accusations of impropriety that have been insinuated regarding the Mayor having a full-time position. When we didn't have an Administrator, Mayor Dale stepped up and did the job for \$11,000 a year. She learned how to run the Township on a daily basis. It's not a question of Mr. Senande's capacity to do his job as the Administrator and the Clerk, he has a full staff in the Clerk's Office that is doing the day to day work that comes through that office whether they have the title or not, is irrelevant. He has a staff there that is fully competent. The issue is the amount of projects that are coming down the pike. Councilman Conlon listed a number of projects that are beginning, Marshall Hill Road, lighting at Dygos Field, working proactively with the Board of Education to work with the constraints of the Highland Act to share resources to benefit the residents. There are plans for the Hillcrest Building and we have been working to obtain the most grant money in the history of the Township. There are a lot of plans and things going on the residents aren't necessarily exposed to unless they were to be on the Council or work for the Municipality. There are projects that need to get done for our Senior Citizens, there is the project at Nosenzo Park off Westbrook Road, and the Senior Center where the cost went up and Mayor Dale went to the County and negotiated to get that grant to match at 50%. Councilman Conlon indicated that he would be making a motion to table the ordinance repealing the Deputy Administrator position because in the future, if the Mayor was not full-time there may be a need for the position. We need to put leadership in place to handle the workload and the projects before us. A Deputy Administrator would use the job as a resume builder and leave, they won't stay. Mayor Dale has a vested interest in the community and can hit the ground running. As far as job tasks, they are listed in the Ordinance but there are tasks that are involved every day that maybe aren't listed. It's a net cost of zero for the tax payers with her foregoing her stipend and also what we would have to pay for someone else to come in and do the job. The Township will benefit tenfold with Mayor Dale becoming full-time.

Councilman Marsden indicated that he is aware that people do not want to pay more in taxes and he pays a lot in taxes as well. The Mayor and Council are trying to keep taxes from going up, and taxes have not gone up for the last 5 years. There are legacy projects that are happening right now and you need to have someone available during the daytime hours to make calls and network and get things done. Residents should hope that the Mayor would say yes to a full-time position because she would do a good job. If you look at municipal government, people get hired and then get trained for a year. The Mayor is up to speed already and that will save us, not hurt us.

Councilwoman Erik indicated that the idea was not just sprung on the Council. They have looked at the facts and the figures and a lot of questions have been answered.

Councilman Chazukow agrees with the other Councilmembers who spoke and indicated that while some of the public audience tonight is fairly well informed, it is not the same as being involved in the day to day activities of the municipality. There is one very large positive that applies and that is, if the Mayor is hired full-time she will be working for the residents in the Township. It will attract a lot of people for the job but we probably won't find anyone better than Mayor Dale.

Councilman Conlon added that there are two sets of checks and balances here. The Mayor is elected by the residents and serves a four year term. Council members serve a three year term, with two members elected each year. The majority of the Council can change within a 13 month time period should there by public outcry. Should the Governing Body feel that there isn't enough work to warrant a full-time Mayor

they can choose to eliminate the position for the year. There is an internal check and balance with the Council members that are elected independently of the Mayor and an external check and balance, where public can vote for a different Mayor. Council members will be listening to all the public comments.

Councilwoman Lichtenberg indicated that she has a vast history with the Township, and has seen a lot of Councils, has been a lifetime volunteer, she personally sought out Mayor Dale when she was on the Council, and worked for her to become Mayor because she saw a person who was a wiz with numbers, and budgets and also was someone who looked ahead to make future improvements. Currently we have numerous projects that need attention right now and she totally supports this concept at this time.

Councilman Goodsir agrees with the other Council members but feels that if the Town paid Mr. Senande as Administrator, and paid for a Clerk and then paid for an Assistant Administrator it would be about the same. If we hired someone else, they probably wouldn't be from here, they would need to be trained and and they probably wouldn't stay here. He is on board with the concept.

Councilwoman Lichtenberg added that the Township is also unique because of the Highlands restrictions and the size being 82 square miles. The Mayor has helped so much, getting grant money and other things. It is just different than being an inner city or a one or three mile town.

Mayor Dale indicated that West Milford is the third largest Township in the State of New Jersey. We have 190 miles of Township roads, 35 miles of County roads, 9 miles of State highway, 9385 catch basins and storm water inlets, so whereas we are not as big in population as some other Towns mentioned by the public, we do not as far as infrastructure goes, and we may be 10-20% larger. We have 17 lakes, one bistate lake, we are 100% in the Highlands and are one of the 3 municipalities that is 100% responsible for water preservation, having Newark Watershed and the Highlands. Mayor Dale indicated she believes the public can see how invested she is in the Township, and would invite anyone who wants to shadow her to do so. Mayor Dale would appreciate it if people would not speak negatively about our Township employees, it's rude. She welcomes comments and free speech in the public forums, but requests comments be above the belt and focus on the actual facts. Mayor Dale indicted that the major projects are not typical projects and are not day to day operations. Mayor Dale thanked the Council, no offer has yet been made, and she thanked the public for showing up and asking questions because the public does have the right to know exactly why decisions are being made and the transparency continues. Posting on social media, without the facts is dangerous but people can do it, she would just ask that people keep it professional.

Seeing no other Council members wishing to speak, Councilman Chazukow made a motion to close the Council comment portion. Seconded by Councilman Goodsir. All were in favor.

WHEREAS, the Mayor and Township Council have determined that permitting microbreweries and similar establishments as defined herein in appropriate locations would be beneficial to the general welfare of the community; and

NOW THEREFORE, BE IT ORDAINED, by the Township Council of the Township of West Milford, in the County of Passaic, and State of New Jersey as follows:

SECTION 1. Chapter 420 "Land Use Procedures" is amended to read as follows:

"§ 420-6 Definitions.

CRAFT DISTILLERY

A craft distillery is a distillery holding a craft distillery license issued by the State of New Jersey as defined by N.J.S.A. 33:1-10 3d producing up to 20,000 gallons of distilled alcoholic beverages per year. The holder of this license shall be entitled to sell this product at retail to consumers on the licensed premises of the brewery for consumption on the premises, but only in connection with a tour of the distillery, or for consumption off the premises in a quantity of not more than five liters per person, and to offer any person not more than three samples per calendar day for sampling purposes only. Sampling means the gratuitous offering of an open container not exceeding 1/2 ounce serving pursuant to licensure issued by the Director of the State Division of Alcoholic Beverage Control (ABC).

MICROBREWERY

A microbrewery is a brewery holding a limited brewery license issued by the State of New Jersey as defined by N.J.S.A. 33:1-10.1b, producing less than 15,000 barrels of 31 gallons of malt beverage per year. The holder of this license shall be entitled to sell this product at retail to consumers on the licensed premises of the brewery for consumption on the premises, but only in connection with a tour of the brewery, or for consumption off the premises in a quantity of not more than 15.5 fluid gallons per person, and to offer samples for sampling purposes only pursuant to licensure issued by the Director of the State Division of Alcoholic Beverage Control (ABC).

WINERY

A winery is a business operating for consumption of wine on or off the winery's premises, and for sampling purposes for consumption on the premises, in order to showcase New Jersey viniculture when operated by one who holds a license permitting same issued by the Director of the State Division of Alcoholic Beverage Control (ABC) and who operates as permitted by the ABC regulations."

SECTION 2. Chapter 500 "Zoning" is amended to include the following new section as follows:

Article III Residential District

§ 500-8 Principal permitted uses on the land and in buildings.

M. Microbreweries, craft distilleries, brewpubs, and wineries in the R-3 and R-4 Districts on lots greater than or equal to five (5) acres and in accordance with applicable State regulations."

WHEREAS, Township Council herein recognizes the need for the Mayor to serve in various capacities and positions, on behalf of the Township and beyond a part-time role.

NOW THEREFORE BE IT ORDAINED, by the Township Council of the Township of West Milford, Passaic County, New Jersey, that only Section 15-7, Powers and duties of Mayor, shall be repealed in its entirety and replaced as follows:

 - 6. Managing Township public relations, including social media; and
 - 7. Serving as Joint Insurance Fund and Health Insurance Fund Commissioner.
- **SECTION 2.** All ordinances of the Township of West Milford, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.
