## **Discussion Items / Official Communications**

Cannabis Ordinance Amendments- Councilman Conlon began by discussing the hours of operation. He indicated that he didn't see an issue with businesses opening earlier to capitalize on sales during the morning commute. Councilman Chazukow has had conversations with some of the dispensary owners and suggested on behalf of Soulflora that businesses be allowed to open as early as 7 a.m. He was not sure what the rest of the Council thought about possibly limiting it to the Route 23 overlay zone. While he can see the logic of doing that it could be considered an unfair advantage. There was some discussion about when bars are allowed to serve alcohol. Councilman Chazukow also suggested that cannabis businesses be allowed to stay open until midnight. Mayor Dale indicated that hours of operation are determined by local government not the State. Councilman Marsden indicated that the opening time was set for 9 a.m. originally, due to school buses being out and it being commute time. Councilman Conlon indicated that he was not in favor of the hours applying to the highway, and that it should be applied to all or none. He would support it for everyone. Consensus was given to make the change to operating hours from 7 a.m. to midnight for 7 days of

the week.

Regarding the number of licenses, Councilman Conlon reminded everyone that there had been a proposal at the January 17, 2024 Council meeting to allow the initial round of 10 licensees to open and stay open until such time as they cease operation. And licenses would not be reissued unless the number was less than 5. At the time it was determined that it was kind of premature to enact that measure. Now that all 10 are open or soon to be, now is the appropriate time to discuss the issue. Councilman Marsden indicated that the thought is if you would rather have 10 businesses that were struggling or 5 that were thriving, or 7 or 8 or 9. His thought is that the market will bear out the number. Councilman Chazukow indicated that the ordinance needs to have more comprehensive text regarding the issue of a cannabis licensee that may want to sell the business. A new license would need to be issued to the new owner. If a building were to burn down or become uninhabitable, that isn't an indication of the market being over saturated . If someone wants to change location they should be allowed to relocate within the Township, not be forced out. Councilman Marden indicated that there should be a mechanism in place for someone who has followed the rules and built up a business to be able to transfer that business to a family member or someone else. Councilman Conlon agreed 100%. Even though it would be a transfer of the existing business, it is technically a new license. Administrator Senande indicated that with the current ordinance there would be a new license and Council approval would be required. The amendment would bypass Council approval if the transfer occurs. He indicated that it could be amended to allow someone to transfer to a new business owner. Mayor Dale indicated with the hypothetical of a building burning down that the owner would have to go and get a new license for the new site because licenses are site specific. Administrator Senande indicated that if the business were to go to a new location it would be like starting from scratch and they would have to go through the entire process all over again. It is not like just moving to a new building and putting up a sign. We can work on the language for that scenario.

Councilman Chazukow indicated that he was not in favor of reducing the number of licenses that are allowed in Town. He would like the ordinance to be true to it's intention of not oversaturating the market and not something that is perceived as an intention to push businesses out of the Township that we have worked so hard to attract. We have about 30 alcohol licenses currently and he finds it difficult to see going from 10 cannabis businesses down to 5 as being fair. He proposed changing the reduction from 5 to 7. He prefers to let the smaller business owners get an opportunity. Councilman Goodsir indicated that the idea is not anti-cannabis, it is pro-business. Councilman Conlon indicated that the intention of the ordinance is not to harm the existing operators. It is to allow the market to dictate how many businesses to have. He feels it is best to do something, so the public doesn't think we are turning into "Weed Milford". The perception is not accurate and not a fair smear to put on the business owners who are operating with high compliance and regulation in a highly scrutinized industry. He is okay with the number going from 5 to 7 and wants the public to know that we are not taking 3 of you out. Councilman Chazukow indicated that there are still unlicensed cannabis businesses still operating in Town and they are a problem. He would like to see them stop taking a slice of the pie, so that the licensed operators get what they deserve. He would like to see the unlicensed operators put out of business. Councilmembers Marsden, Goodsir and Erik wanted the number of businesses to be 5. Councilman Conlon was fine with 5 or 7. Councilman Chazukow gave consensus but with the additional language regarding selling and relocating a business. Council gave consensus for the number to be 5.

Administrator Senande spoke about special events. There had been a complaint from a constituent regarding events that have been happening. There has been discussion about additional limits. If the event should be screened. The events can happen more frequently since we do have 10 dispensaries that could possibly each have 6 events, so that would equal 60 days a year and they can have two day events and that would make the number 120 days of special events per year. Councilman Marsden indicated that if businesses hold special events, they need to have security and take responsibility for what takes place. If people are violating the ordinance there has to be a mechanism to say that you are not allowed to have special events. Mayor Dale indicated that the business owners need to take responsibility and realize where they are located. Along the highway it wouldn't be a problem but if the dispensary is located in the middle of Town or in a neighborhood, they would need to show respect. Councilman Conlon wants to make sure there is some type of parking and security plan for the special events. Administrator Senande indicated that the police usually ask for parking and security plans but it would be good to put it in the ordinance so that it is automatic.

Chief Sommerville had prepared some information for the Mayor, Council and Public regarding consumption licenses. He had prepared a list of pros and cons. The pros were that a licenses lounge offers a controlled, monitored setting for consumption, reducing the likelihood of cannabis use in public space, like parks or near schools. Tax revenue and business licensing fees could contribute to local services including public safety initiatives. The police department would have access to security compliance inspections. The police have done all the inspections so far and things are going well with the cannabis businesses in Town currently. Some of the cons for consumption lounges

include DWI enforcement. The primary concern for public safety is the potential for impaired driving. Roadside cannabis impairment is harder to detect than alcohol. Patrons leaving a lounge may present a greater risk to road safety and enforcement would require additional training and resources Unlike alcohol where there is a test to see if you are over the limit, the minute you ingest cannabis and get into your car and pull out, it is an automatic DWI. There is no quantitive test for it. If an officer happened to be parked across the street and saw someone pull out in their car they could be arrested for DWI. Another con is that it would require increased patrols and more training coordinated with State agencies. These things are all manageable but will be a cost to the Town. Although lounges have an age restriction of 21 or older, their presence may contribute to the normalization of cannabis among minors. This requires on going education and preventative programs in schools and community settings. Another issue is the food and beverage loophole. New Jersey does not permit consumption lounges to sell or provide food or drink on site. However patrons are legally allowed to bring their own. This creates a significant challenge to law enforcement. Individuals may be tempted to sneak in alcohol or put cannabis in food items that was not legally purchased or tested which opens up the door to unregulated product consumption and undermines the State compliance goals and increases the risk of overconsumption or unsafe behavior. The odor, noise and loitering may become issues for nearby residents. If the building has more than one tenant second hand smoke may become an issue. That could affect families, customers, vulnerable populations leading to complaint, health concerns and disputes. Atlantic City and Jersey City allow cannabis lounges but they have mass transit and West Milford doesn't have that and nobody walks. It also leaves the cannabis business open to liability if someone gets in a crash. There is nothing currently for cannabis that is similar to the alcohol last drink report.

Mayor Dale thanked Chief Sommerville for his report and asked the Council if they wanted to move forward with consumption lounges. Council members Erik, Lichtenberg, and Marsden were not in favor. Councilman Conlon said he thought it was premature. Councilman Marsden indicated that he wanted to hear from the operators now that they have heard the concerns presented. Councilman Chazukow said that it would be hard to have consumption lounges, but it could be done and also agrees there is no rush. He suggested that anyone wishing to have a consumption lounge put together a plan for parking and security and address the issues that have been presented. If the issues can be addressed he doesn't see why future governing bodies would say no. Mayor Dale made the point that the business operators do not have a way to test for intoxication. Councilman Chazukow indicated that the laws around consuming cannabis are more strict and anyone consuming it and then getting into a car would be foolish. There was more discussion about not having mass transit and how it would be great to partner with a ride share of some type. Councilman Marsden would like to see evidence that there is more benefit than risk, and currently he doesn't. Consensus was not given for consumption lounges.

Councilman Chazukow returned to the matter of special events. He has no problem with codifying some of the details mentioned before, the screening and security and parking issues. He indicated that special events are critical for these entrepreneurs. Councilwoman Lichtenberg indicated that the hours for special events shouldn't go until midnight. Mayor Dale indicated that they could only go until 10 p.m. Administrator Senande indicated that with alcohol being consumed it is considered a beer garden and there are specific State rules and with cannabis there are no rules except to be 21 years of age or older. So we have no restrictions as it is an age restricted product. There needs to be more restrictions because we don't have the ABC involved in the process. ABC requires fencing and security, ingress and egress conditions and other things. Administrator Senande indicated that the ordinance was written geared toward a grand opening, not for special events to be held every month. Mayor Dale confirmed that this was for an outdoor permit. Administrator Senande indicated that the amount as it stands now is 6 events with a maximum of two days equals 12 days total.

Consensus was given to allow (2) two-day permits.

Administrator Senande indicated that no one has applied for a two-day permit. The total number of special event permits allowed will be 6 and owners will be allowed to use them consecutively. Administrator Senande indicated that they could have (2) 3 day events if the business owner chose to do so. Consensus was given by the Council.

Coucilman Chazukow asked about the other items, the parking, security, and screening. Administrator Senande indicated that he was going to try to match what the State requires for liquor licenses since it is still the 21 year old age limit. He is going to put in those restrictions because currently there are none for cannabis consumption. Councilman Conlon indicated that there are some locations where an area may be screened off by a building or something else and other areas are more out in the open. The flip side is that the entire event doesn't need to be shielded, as the idea is to bring the public in. Administrator Senande indicated that perhaps a certain area would be blocked off. No one is going to stop someone smoking in the parking lot.

#### **Public Comments**

Rich Lyons, the chief legal officer at Jersey Roots indicated that there needs to be a crackdown on the illegal businesses in Town because they are directly affecting all of the businesses who have gone about doing things the right way. Anything Council can do on that front would be greatly appreciated. He indicated that with regard to saturation, the illegal businesses are the biggest issue. Mr. Lyons feels that with regard to a license transfer as long as it is the same entity, that would restrict it to a stock sale which might not be typical in the market. He would like it to have free assignability, whether it is a stock or an asset purchase which is the more generalized structure of any type of transfer if it were to happen in the future.

Michelle Liebau from 4Twenty Somewhere thanked the Council and Mayor for all their work over the last three years. She stressed the importance of knowing your audience, and that residents don't want large parties in the parking lot. Be mindful that it makes her dispensary look bad and she doesn't appreciate that. She would like to see the Council spend more time on special events, because even the CRC is struggling with it. She would like to have West Milford be the example for what looks good for an event. She suggested that the dispensary owners should get together as a dispensary committee and make suggestions and come up with ideas with the Council. She invited all to come to her dispensary and ask questions and it will help lessen the stigma around cannabis.

The owners from Beyond Bleaf invited everyone to their grand opening on May 24, 2025. It is much appreciated that everything is coming from a solution space mindset. They are open to answering questions, partnering with other businesses and the community to better service West Milford.

Seeing no one else wishing to speak Councilman Conlon made a motion to close the public portion. Councilman Goodsir seconded. All were in favor.

#### Agenda No. XI

#### **Council Comments**

Councilman Goodsir indicated that although he goes to a lot of grand openings where everyone is saying they are the best cannabis businesses have the mindset that they want to do well and have their fellow businesses do well too.

Councilman Conlon indicated that it will be important that businesses are sellable down the line. He thanked the public for thanking Council because it is a lot of work even though they signed up for it, and nights like this where we honor the police and a good Samaritan and can speak openly with the public because people get a better understanding of things. The Town is not allowing cannabis businesses just to make money, but the success of these businesses directly affects and benefits the operation of the Township. It directly benefits the taxpayers because it means certain costs are not passed onto them.

Councilman Goodsir indicated that it was the 10<sup>th</sup> year with a zero increase in taxes, and we lost funding from the State, but if we did not have the revenue from the cannabis businesses taxes would have had to be raised.

Councilman Chazukow is excited to see the businesses grow and succeed. Having a manufacturer or cultivator is big time, it's a Statewide business. He indicated that the evening was difficult for him because he is pro-freedom and a lot of the conversation was about restricting the market but he's okay with things as long as the political process is being followed. He thanked everyone for coming out tonight. There has to be some type of enforcement for the illegal cannabis businesses.

Councilwoman Erik likes the idea of having a group that comes together with a Council member liaison. The original ordinance was based on information from the cannabis business owners and the ideas they had.

Councilman Conlon thanked Councilman Chazukow for all the work he has done and the information he has presented on the subject. He thanked everyone for having an open mind throughout the entire process.

## ORDINANCE TO EXCEED THE CALENDAR YEAR 2025 MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

**WHEREAS**, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

**WHEREAS,** N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

**WHEREAS**, the Township Council of the Township of West Milford in the County of Passaic finds it advisable and necessary to increase its CY 2024 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

**WHEREAS**, the Township Council hereby determines that a 1.00% increase in the budget for said year, amounting to \$399,034.91 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

**WHEREAS** the Township Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

**NOW THEREFORE BE IT ORDAINED**, by the Township Council of the Township of West Milford, in the County of Passaic, a majority of the full authorized membership of this Governing Body affirmatively concurring, that, in the CY 2025 budget year, the final appropriations of the Township of West Milford shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.50%, amounting to \$1,396,622.18, and that the CY 2025 municipal budget for the Township of West Milford be approved and adopted in accordance with this ordinance; and,

**BE IT FURTHER ORDAINED,** that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

# RESOLUTION OF THE TOWNSHIP OF WEST MILFORD COUNTY OF PASSAIC AND STATE OF NEW JERSEY FOR SELF-EXAMINATION OF THE 2025 BUDGET RESOLUTION (AS REQUIRED BY DCA)

**WHEREAS**, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

**WHEREAS,** pursuant to N.J.A.C. 5:30-7.2 through 7.5, the Township of West Milford has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial Officer has determined that the local government meets the necessary conditions to participate in the program for the 2025 budget year.

**NOW THEREFORE BE IT RESOLVED** by the Governing Body of the Township of West Milford that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the Governing Body has found the budget has met the following requirements:

- 1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
  - Payment of interest and debt redemption charges
  - b. Deferred charges and statutory expenditures
  - c. Cash deficit of preceding year
  - d. Reserve for uncollected taxes
  - e. Other reserves and non-disbursement items
  - Any inclusions of amounts required for school purposes.
- 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A.
  - 40A:4-45.3 et seq., are fully met (complies with CAP law).
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
- 4. That pursuant to the Local Budget Law:
  - a. All estimates of revenue are reasonable, accurate and correctly stated,
  - b. Items of appropriation are properly set forth

- (c) The supplemental debt statement required by said Local Bond Law has been duly made and filed in the office of the Township Clerk and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey, and such statement shows that the gross debt of the Township as defined in said Local Bond Law is increased by the authorization of the bonds and notes provided for in this bond ordinance by \$3,899,000, and the said obligations authorized by this bond ordinance will be within all debt limitations prescribed by said Local Bond Law.
- (d) Amounts not exceeding \$450,000 in the aggregate for interest on said obligations, costs of issuing said obligations, engineering costs and other items of expense listed in and permitted under Section 40A:2-20 of said Local Bond Law may be included as part of the costs of said improvements and are included in the foregoing estimate thereof (and, in particular, \$50,000 of such costs allocable to costs of issuance have been included in the improvement described in Section 3(f) of this bond ordinance).
- **Section 5.** The funds from time to time received by the Township on account of the \$495,490 grant referred to in Section 1 of this bond ordinance shall be used for financing the improvement or purpose described in paragraph (a) of Section 3 of this bond ordinance by application thereof either to direct payment of the costs of said improvements or purposes, or to payment or reduction of the authorization of the obligations of the Township authorized therefor by this bond ordinance. Any such funds so received may, and all such funds so received which are not required for direct payment of the costs of said improvements or purposes shall, be held and applied by the Township as funds applicable only to the payment of obligations of the Township authorized by this bond ordinance.
- **Section 6.** All bond anticipation notes issued hereunder shall mature at such times as may be determined by the chief financial officer, the acting chief financial officer or the treasurer (the "Chief Financial Officer"), provided that no note shall mature later than one year from its date. # ORDINANCE OF THE TOWNSHIP OF WEST MILFORD, COUNTY OF PASSAIC, STATE OF NEW JERSEY AMENDING CHAPTER 348, TATTOO PARLORS AND TATTOO ARTISTS, TO ALLOW TEMPORARY ESTABLISHMENTS

**WHEREAS**, the Township regulates Tattoo Parlors and Tattoo Artists, for the betterment of the public's health, safety and welfare; and

**WHEREAS**, the Township wishes to expand Tattoo Establishments to temporary locations, and so as to allow them at events as may be held within the Township; and

**WHEREAS**, while allowing such temporary locations, it shall continue and remain unlawful for any person to engage in tattooing without first obtaining approval from the Township Health Department to engage in such activity; and

**WHEREAS**, temporary locations shall be subject to the same licensing fee as for other tattoo establishments.

**NOW THEREFORE BE IT ORDAINED**, by the Mayor and Township Council of the Township of West Milford, County of Passaic, and the State of New Jersey that the Code of the Township of West Milford, Chapter 348, Tattoo Parlors and Tattoo Artist, shall be amended only to add the following new Section Chapter 348—7, Temporary Establishments:

#### SECTION 1. § 348-7 Temporary Establishments

- A. Temporary Establishments are herein authorized, subject to the approval of the Township of West Milford Health Department. It shall be unlawful for any person to engage in the business of or operating a temporary establishment where Tattooing is performed without first obtaining a license from the Township of West Milford Health Department to engage in such activity.
- B. An application for any temporary establishment must be accompanied by the fee as set forth in Chapter 135-35.

**SECTION 2.** All ordinances or parts of ordinances of the Township of West Milford inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.
