RESOLUTION OF THE TOWNSHIP OF WEST MILFORD, COUNTY OF PASSAIC, STATE OF NEW JERSEY APPROVING THE RENEWAL OF PLENARY RETAIL CONSUMPTION LICENSE FOR THE 2025 - 2026 LICENSE YEAR

WHEREAS, application has been filed for renewal of Plenary Retail Consumption License for the 2025-2026 license term within the municipality; and

WHEREAS, the municipality has received the required Alcoholic Beverage Retail Licensee Clearance Certificates for renewal from the Division of Taxation for these licenses; and
