



INTERIM EXECUTIVE DIRECTOR


Mr. Roeder prepared a Power Point Presentation which was emailed to Commissioners and Professionals for this evening's meeting. Mr. Roeder reported that payroll numbers are running under budget due we are down one plant attendant.

Mr. Roeder reported that the utilities cost is running higher average at this point, which is not going to get better due the notice of 20% increase in cost. Septage revenue and sludge removal are running below the budget guideline due to the mild and dry weather we are experiencing. The monthly plant flow remains within our permit gallons per day.





Mr. Roeder stated that at this point in the budget we are not as strong as last year, reminding the Board that we are coming into our busy season.



Mr. Roeder stated that Chapman Environmental is over budget largely due to the CIP project, we have not been able to submit the bills to the state for reimbursement, we are close to being able to submit. We are on budget beside the CIP.

Mr. Roeder reported that as if March 25, 2025, we had not received 7 of 11 February bank Statements (all from the Bank of New York and therefore no cash status report in provided.

Plant Operations Supervisor

Mr. Leslie reported that operationally outside the plant is working well. The flow meters inside and outside both at the main plant and at Haskell Pump Station have been calibrated so that we are getting accurate readings. Mr. Leslie stated that the maintenance team is doing an in creditable job,

they have been replacing gear boxes and motors. Chairman Covelli asked if there were any questions from the Commissioners or Professionals for Mr. Roeder or Mr. Leslie on the operations report.

ENGINEERING REPORT

Ms. Diaz stated that the NJIB is on the final review of the documents, NJIB asked for a resilience report, which will be done in the next coming days, they also asked for a bidding schedule which Ms. Diaz said is good news.
